ROAD TRAFFIC REGULATION ACT, 1984, SECTION 14 AS AMENDED THE ROAD TRAFFIC (TEMPORARY RESTRICTIONS) ACT 1991 AND ALL OTHER ENABLING POWERS

POPLAR WALK, CROYDON & STATION ROAD, WEST CROYDON TEMPORARY RESTRICTION OF TRAFFIC

- 1. Croydon Council HEREBY GIVE NOTICE that to facilitate footway works, they have made an Order the effect of which would be to temporarily restrict traffic movements in Poplar Walk, Croydon and Station Road, West Croydon.
- 2. Whilst the said works are taking place:
- a) Station Road will be closed to vehicular traffic between its junctions with Wellesley Road and North End during the dates shown in the Schedule to this Notice.
- b) Poplar Walk will be closed to vehicular traffic between its junctions with Wellesley Road and North End during the dates shown in the Schedule to this Notice.
- c) The south-eastern footway of Station Road and the north-western footway of Poplar Walk will be closed to pedestrians between the above-mentioned junctions during the dates shown in the Schedule to this Notice.
- 3. The Order will come into operation on the 18 August 2023, and it is anticipated that the works will be carried out in three phases, as detailed in the Schedule to this Notice, and completed in February 2024. However, the Order will remain in force for 18 months to be reintroduced should further works be required.
- 4. Whilst the closures are in place the alternative routes for vehicular traffic will be as detailed below. Pedestrians will be diverted into a walkway in the carriageway.
- Station Road closure diversion: via Wellesley Road north and south, Croydon Flyover, Pump Pail South, Old Town, Roman Way, Sumner Road, and London Road.
- Poplar Walk closure diversions: via Tamworth Road, Drummond Road, Reeves Corner, Old Town, Croydon Flyover and Wellesley Road, or via St James's Road, Sumner Road, Mitcham Road, Roman Way and then pick up the above diversion route.
- 5. The restrictions shall not apply in respect of:
 - (a) any vehicle or person involved in carrying out the said works.
 - (b) any vehicle being used for fire brigade, ambulance or police purposes.
 - (c) anything done with the permission of a police constable in uniform or a Civil Enforcement Officer.
