Early Years Block - Final Outturn 2020/21

Summary and recommendation:

This paper sets out:

The updated outturn position of the Early Years block following the November 2021 ESFA adjustments.

1. Background

- **1.1** This paper aims to update Schools Forum with the final outturn position of the Early Years block following the final published DSG allocation in November 2021. The initial outturn report submitted to Schools Forum in July 2021 reported an indicative year -end position of £2.570m. Reference Item 4 dated 12/0/7/2021, table 5.
- 1.2 However, the final position based on the November published Early Years DSG funding for 2020/21 reported a claw back of almost £774.3k hence the final position is now £2.123m. Please refer to table 1, line number 19.
- 1.3 This amount is expected to increase by another £20.1k to a final position of £2.143m related to refund of overpayment to maintained Nurseries Schools. Reference Table 1 line 20.
- 1.4 Please note that the Early Years team is expected to use the stand-alone system reconciliation figures (£35,936 and £53.,044) ** for reporting the final position on line 10 and 11 representing Pupil premium and Disability Access Fund once completed and validated.

2. <u>Methodology for distributing the reserves to the sector</u>

2.1 The Early Year Working group is currently considering the most objective, feasible and acceptable means of distributing approximately 80% of the Early Years reserves in April 2022.
