Dear Resident

Start of Resident Consultation - Regina Road

We wrote to you recently letting you know of plans to start consulting residents formally about the future of homes in Regina Road and the surrounding area.

I am writing again to confirm that the statutory consultation to be held with residents will start on Tuesday, 13 December 2022. It will run over a six-week period to help decide the best way of providing warm, modern homes for you.

During this phase of the consultation, we will be asking for your views on the following:


- Option to either refurbish or rebuild homes that are included in the consultation area
- Draft Tenant Offer (if the blocks are demolished and rebuilt)
- Draft Leaseholder & Freeholder Offer (if the blocks are demolished and rebuilt).

The consultation will run for six weeks and officially end on Thursday, 26 January 2023. It provides an opportunity for you to formally tell us your views around refurbishment or rebuilding and following further work around the potential options, you will be invited to vote in a resident ballot in spring 2023.



How will I know if my home is affected?

Your home is included in the consultation area if it is within the red line shown on this map.



How can I find out what it means for me?

Alongside this letter you will have received information which sets out what you can expect from the council if your homes are refurbished or redeveloped.

These commitments to you are often called a **'Tenant Offer'** or a **'Leaseholder & Freeholder Offer'**. They will be used as the basis for the Landlord Offer for a resident ballot in spring 2023 to determine the future of this part of the estate.

You may have read in the news that Croydon Council has issued a Section 114 Notice which stops all but essential spending on most council services. I want to reassure you that this announcement will not affect or impact on our decision to either refurbish or rebuild the blocks.
