

DISABLED PERSONS PARKING PLACES – SCHEDULE 229

The Croydon (Prohibition and Restriction of Stopping, Loading and Waiting) and
(Free Parking Places) (No.10) Order 2023

The Croydon (On-Street Charged-For Parking Places) (No.10) Order 2023

NOTICE IS HEREBY GIVEN that Croydon Council on 02 May 2023 made the above Traffic Orders under section 6 of the Road Traffic Regulation Act 1984, as amended and all other enabling powers.

1. The general effect of the Orders will be to:

a) **Revoke the disabled parking places in the vicinity of No. 29 Beverstone Road, Thornton Heath, No. 161 Cecil Road, Croydon, No. 595 Davidson Road, Croydon, No. 38 Elmside, Fieldway, New Addington, No. 35 Harewood Gardens, South Croydon, No. 32 Kemerton Road, Croydon, No. 6 Lenham Road, Thornton Heath, No. 27 Parkview Road, Croydon, Nos. 10 and 38 Sutherland Road, Croydon, No. 395 Sydenham Road, Croydon, and No. 16 Wiltshire Road, Thornton Heath.**

b) **Designate new parking places at which vehicles displaying a disabled persons' badge may be left without charge or time limit in the following locations.**

Addington Village Road, Croydon	Outside New Place (replaces one space at the eastern end of the inset free parking bay)
Birchfield Close, Coulsdon	Adjacent to the flank wall of No. 51 (replaces one space in Housing Estate parking area).
Cecil Road, Croydon	Outside No. 21 and partially across the frontage of No. 19 (replaces one permit/payment parking bay).
Fairlands Avenue, Thornton Heath	Outside No. 95
Fernwood, Croydon	Adjacent to the junction of Fernwood and Inglewood (replaces one free parking bay)
Grasmere Road, South Norwood	Outside No. 61 and partially across the frontage of No. 59
Green Lane, Thornton Heath	Opposite No. 86 (Bay fully on footway)
Green Lane, Thornton Heath	Outside No. 169
Gresham Road, South Norwood	Partially across the frontages of Nos. 1 and 2 (replaces one permit/payment parking bay).
Grove Road, Thornton Heath	Outside No. 17
Haydn Avenue, Purley	Outside No. 60
King Henry's Drive, New Addington	Opposite No. 431 (bay to be provided in hard standing area on the green at 90 degrees to the kerb)
Malden Avenue, South Norwood	Outside No. 54
Mayfield Crescent, Thornton Heath	Outside No. 8
Nicola Close, South Croydon	Outside No. 2 and partially across the frontage of No. 4
Purley Oaks Road, South Croydon	Outside No. 8
Stratford Road, Thornton Heath	Outside No. 2
Windham Avenue, New Addington	Outside No. 106 (in Hare's Bank)
Wingate Crescent, Croydon	Outside No. 56 (replaces one space in partial footway bay)
Walton Green, New Addington	Adjacent to the flank wall of Nos. 2 to 24 Dunsfold Way (partial footway bay)

2. Copies of the Orders, which will come into operation on 08 May 2023 and of all associated Orders can be inspected between 9am and 4pm, Monday to Friday inclusive, until the last day of a period of six weeks beginning with the date on which the Orders are made by appointment with the Parking Design Team, at Bernard Wetherill House, 8 Mint Walk, Croydon, CR0 1EA (telephone 020 8726 6000 and ask for Parking Design). Alternatively all related documents or further information can be requested by email to Parking.Design@croydon.gov.uk.

3. Any person desiring to question the validity of the Orders or of any provision contained therein on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act, 1984 or that any of the relevant requirements thereof or of any relevant regulations made there under have not been complied with in relation to the Orders may, within six weeks of the date on which the Orders were made, make application for the purpose to the High Court.
