ROAD TRAFFIC REGULATION ACT, 1984, SECTION 14 AS AMENDED
THE ROAD TRAFFIC (TEMPORARY RESTRICTIONS) ACT 1991 AND ALL OTHER
ENABLING POWERS
OLD TOWN & WADDON ROAD, CROYDON
TEMPORARY PROHIBITION OF TRAFFIC & PARKING

1. Croydon Council, HEREBY GIVE NOTICE that to enable gas main remediation works to take place on behalf of SGN they intend to make an Order the effect of which will be to temporarily prohibit traffic movements in Old Town, Croydon, and to temporarily prohibit traffic movements and parking in Waddon Road, Croydon.
2. Whilst the said works are taking place carriageway and footway closures, speed limits and parking suspensions will apply as detailed below.

Road Name	Location of Restrictions	Period of Restrictions
Old Town	The nearside north-west bound lane of Old Town from its junction with Duppas Hill Lane to a point opposite the common boundary of Nos. 25 and 27 Old Town.	Carriageway closed from 05 February to 15 March 2024
Old Town	The south-western footway between a point opposite the junction with Salem Place and a point opposite the common boundary of Nos. 25 and 27 Old Town	Footway closed from 05 February to 15 March 2024
Old Town	The offside north-west bound lane of Old Town from its junction with Duppas Hill Lane to a point opposite the common boundary of Nos. 25 and 27 Old Town.	Speed limited to 30mph from 05 February to 15 March 2024
Waddon Road	Between a point opposite the south-eastern flank wall of No. 16 Waddon Road and the cul-de-sac adjacent to No. 3 Waddon Road.	Carriageway closed from 01 March to 22 March 2024
Waddon Road	Between a point opposite the south-eastern flank wall of No. 16 Waddon Road and the cul-de-sac adjacent to No. 3 Waddon Road.	Parking suspended from 01 March to 22 March 2024

3. Whilst the footway closure is in place in Old Town, pedestrians will be diverted into a walkway in the carriageway. During the closure of the nearside north-westbound lane of Old Town, access to the fire station will be maintained.
4. The Order will come into operation on 05 February 2024 and it is anticipated that the works will be carried out and completed as shown above. However, the Order will remain in force for 18 months to be reintroduced should further work be required.
5. These restrictions shall not apply in respect of:
 - (a) any vehicle involved in carrying out the said work.
 - (b) any vehicle being used for fire brigade, ambulance, or police purposes.
 - (c) anything done with the permission of a police constable in uniform or a Civil Enforcement Officer.
