## PN330 - CROYDON COUNCIL ROAD TRAFFIC REGULATION ACT, 1984 SECTION 14, AS AMENDED THE ROAD TRAFFIC (TEMPORARY RESTRICTIONS) ACT 1991 INSTALLATION OF CYCLE HANGARS - VARIOUS LOCATIONS TEMPORARY PROHIBITION OF PARKING

- 1. Croydon Council, **HEREBY GIVE NOTICE** that to facilitate works to install cycle hangars they intend to make an Order the effect of which would be to temporarily restrict parking in the sections of roads listed in the Schedule to this Notice.
- 2. Whilst the said works are taking place parking will be suspended and waiting and loading restrictions will apply at any time in the sections of road listed in column 2 of the Schedule to this Notice.
- 3. The Order will come into operation on the 19 February 2024, and it is anticipated that the works will be completed by 01 March 2024. However, the Order will remain in force for 18 months to be reintroduced should further works be required. The prohibitions will only apply during such times and to such an extent as shall from time to time be indicated by traffic signs.
- 4. These restrictions shall not apply in respect of:
  - (a) A vehicle involved in carrying out the said works.
  - (b) A vehicle being used for fire brigade, ambulance, or police purposes.
  - (c) Anything done with the permission of a police constable in uniform or a Civil Enforcement Officer.

1. ROAD	2. LOCATION OF WAITING & LOADING RESTRICTION / PARKING SUSPENSION
Auckland Road, Upper Norwood	The south-west (odd-numbered) side, from a point 1.5m south-east of the common boundary of Nos. 39 and 41 Auckland Road for 10 metres north-westwards.
Beulah Road, Thornton Heath	The north-west (odd-numbered) side, from the end of the pedestrian crossing zig-zag markings outside No. 117, for 10 metres north-eastwards.
Mersham Road, Thornton Heath	The north-west (odd-numbered) side, from the common boundary of Nos. 109/111 and 113/115 for 10 metres north-eastwards.
Norbury Avenue, Thornton Heath	The north-east (even-numbered) side, from a point 0.5m south-east of the north-western flank wall of No. 2a for 10 metres north-westwards.
Orleans Road, Upper Norwood	The north-east (odd-numbered) side, from a point 4 metres south-east of a point opposite the common boundary of Nos. 24 and 26 for 10m south-eastwards
Oval Road, Croydon	The south-west (odd-numbered) side, from the south-eastern end of the existing permit/payment bay adjacent to the flank wall of No. 23 Leslie Park Road for 10 metres southeastwards.
Queen Mary Road, Upper Norwood	The west (odd-numbered) side, from a point 2m south of the northern boundary of No. 226 Beulah Hill for 10m southwards.
Salisbury Road, South Norwood	The south-east (odd-numbered) side, from a point 12 metres south-west of the junction with Stroud Road for 10 metres south-westwards.
Seymour Place, South Norwood	The north-east (odd-numbered) side, from a point 9 metres north-west of the junction with Belfast Road for 10 metres north-westwards.
Sylvan Hill, Upper Norwood	The north-east (odd-numbered) side from a point 18 metres south-east of the junction with Church Road for 10 metres south-eastwards.
