The Croydon (On-Street Charged-For Parking Places) (Amendment No. F7) Order 20-NOTICE IS HEREBY GIVEN that Croydon Council proposes to make the above Traffic Orders under section 6 of the Road Traffic Regulation Act 1984, as amended and all other enabling powers.
