## BRIGHTON ROAD, COULSDON - TEMPORARY PROHIBITION OF TRAFFIC

- Croydon Council HEREBY GIVE NOTICE that to facilitate works to install bridge protection beams on rail bridge VTB-84, they have made an Order the effect of which would be to temporarily prohibit traffic movements in Brighton Road, Coulsdon.
- 2. During the work:
- a) Brighton Road will be closed to vehicular traffic between the entrance to Coulsdon South Station and the roundabout at the junction with Marlpit Lane.
- b) The footway of Brighton Road will be closed between the entrance to Coulsdon South Station and the roundabout at the junction with Marlpit Lane.
- 3. Whilst the closure remains in force the alternative route for vehicular traffic will be via Brighton Road and Farthing Way. Pedestrians affected by the footway closure will be directed to the opposite footway.
- 4. The Order will come into operation on 07 September 2025, and it is anticipated that the work will be completed as shown below, finishing on 31 October 2025. However, the Order will remain in force for 18 months to be reintroduced should further work be required. The prohibition will only apply during such times and to such extent as shall from time to time be indicated by traffic signs.

- 5. The restrictions shall not apply in respect of:
  - (a) any vehicle or person involved in conducting the said work.
  - (b) a vehicle being used for fire brigade, ambulance, or police purposes, or the purposes of a statutory undertaker in an emergency, such as the loss of supplies of gas, electricity or water to premises in the area, which necessitates the bringing of vehicles into a section of road to which the order applies.
  - (c) anything done with the permission of a police constable in uniform or a Civil Enforcement Officer.
