The Croydon (Prohibition and Restriction of Stopping, Loading and Waiting) and (Free Parking Places) (No. 21) Order 2025

The Croydon (On-Street Charged-For Parking Places) (No. 21) Order 2025 NOTICE IS HEREBY GIVEN that Croydon Council on 20 October 2025 made the above Traffic Orders under section 6 of the Road Traffic Regulation Act 1984, as amended and all other enabling powers.

- 1. The general effect of the Orders will be to:
- a) Revoke the disabled parking places in the vicinity of No. 94 Bensham Grove, Thornton Heath, No. 10 Buller Road, Thornton Heath, No. 67 Hythe Road, Thornton Heath, No. 4 Netley Close, New Addington, and No. 13 Wharfedale Gardens, Thornton Heath.

b) Designate new parking places at which vehicles displaying a disabled persons' badge may be left without charge or time limit in the following locations.

Any person desiring to question the validity of the Orders or of any provision contained therein on the ground that it is not within the relevant powers of the Road Traffic Regulation Act, 1984 or that any of the relevant requirements thereof or of any relevant regulations made there under have not been complied with in relation to the Orders may, within six weeks of the date on which the Orders were made, make application for the purpose to the High Court.
