

**DISABLED PERSONS PARKING PLACES – SCHEDULE 250**

The Croydon (Prohibition and Restriction of Stopping, Loading and Waiting) and  
(Free Parking Places) (No.24) Order 2025

The Croydon (On-Street Charged-For Parking Places) (No.24) Order 2025

NOTICE IS HEREBY GIVEN that Croydon Council on 22 December 2025 made the above Traffic Orders under section 6 of the Road Traffic Regulation Act 1984, as amended and all other enabling powers.

**1. The general effect of the Orders will be to:**

- a) Revoke the disabled parking places in the vicinity of No. 18a Hillside Avenue, Purley, No. 18 Penrith Road, Thornton Heath, and No. 43 Warren Avenue, South Croydon.
- b) Designate new parking places at which vehicles displaying a disabled persons' badge may be left without charge or time limit in the following locations.

<b>Croham Mount, South Croydon</b>	<b>Outside No. 1c</b>
<b>Earlswood Avenue, Thornton Heath</b>	<b>Outside No. 1 and partially across the frontage of No. 3 (replaces one space in a permit/payment bay)</b>
<b>Fairholme Road, Croydon</b>	<b>Outside No. 45 and partially across the frontage of No. 47 (replaces one space in a permit/payment bay)</b>
<b>North Walk, Field Way, Croydon</b>	<b>At the rear of No. 115 North Walk, Field Way</b>
<b>Harcourt Road, Thornton Heath</b>	<b>Outside No. 35 and partially across the frontage of No. 37 (replaces one space in a permit/payment bay)</b>
<b>Kuala Gardens, Norbury</b>	<b>Adjacent to the garages located between Nos. 8 and 10 (bay positioned at 90 degrees to the kerb)</b>
<b>Lancing Road, Croydon</b>	<b>Partially outside Nos. 71 and 73 (replaces one space in a permit/payment parking bay)</b>
<b>Little Roke Avenue, Kenley</b>	<b>Outside No. 82 and partially across the frontage of No. 80 (partial footway parking bay)</b>
<b>Livingstone Road, Thornton Heath</b>	<b>Partially outside Nos. 186 and 188</b>
<b>Macclesfield Road, South Norwood</b>	<b>Outside No. 78</b>
<b>Mersham Road, Thornton Heath</b>	<b>Outside No. 234 and partially across the frontage of 236</b>
<b>Mitcham Road, Croydon</b>	<b>Outside No. 177 and partially across the frontage of 175 (extension of an existing bay by one metre south-eastwards)</b>
<b>Norbury Crescent, Norbury</b>	<b>Outside No. 185 and partially across the frontage of No. 183 (replaces one partial footway bay)</b>
<b>Ross Road, South Norwood</b>	<b>Outside No. 92 and partially across the frontage of No. 90</b>
<b>Waddington Avenue, Coulsdon</b>	<b>Adjacent to the flank wall of No. 1a, Lacy Green, Coulsdon Road – 3-hour max stay disabled parking bay (replaces 3 metres of double yellow lines)</b>
<b>Watcombe Road, South Norwood</b>	<b>Adjacent to the flank wall of No. 217 Portland Road (conversion of an existing disabled bay to a 3-hour maximum stay disabled bay)</b>
<b>Westbourne Road, Croydon</b>	<b>Outside No. 14</b>

2. Copies of the Orders, which will come into operation on 29 December 2025 and of all associated Orders can be inspected between 10am and 6pm, at Croydon Central Library, Katharine Street, CR9 1ET. 3. Any person desiring to question the validity of the Orders or of any provision contained therein on the ground that it is not within the relevant powers of the Road Traffic Regulation Act, 1984 or that any of the relevant requirements thereof or of any relevant regulations made there under have not been complied with in relation to the Orders may, within six weeks of the date on which the Orders were made, make application for the purpose to the High Court.
