Late Night Refreshment (hot food/drink) 23:00–03:00 only.

The premises shall not sell, supply, permit consumption of, or allow customers to bring their own alcohol at any time.

b) The prevention of crime and disorder

A digital CCTV system covering the server, customer area and area immediately outside the entrance shall be installed, maintained and operating whenever open; recordings kept 31 days and provided to Police/Authorised Officers within 24 hours on request.

An incident/refusals log shall be kept (crimes, disorder, refusals, ejections, police attendance), retained 12 months and available on request.

Staff training will be provided in the form of induction and refreshers on refusing service to intoxicated persons, queue management and dispersal; records kept 12 months.

Maintain a driver compliance log (complaints, warnings, actions), retained 12 months.

Notify third-party platforms of requirements and remove/restrict drivers who repeatedly breach them; keep evidence of steps taken.

c) Public safety

Hot-food service areas supervised whenever open; spillages cleared promptly; a suitable first-aid kit kept on site.

Maximum occupancy (if set by risk assessment/authority) shall not be exceeded.

No charging of e-bike/e-scooter batteries by drivers inside the customer area or on the pavement.

d) The prevention of public nuisance

After 23:00 doors and windows closed except for access/egress; no external speakers at any time.

Prominent exit notices requesting customers leave quietly and not loiter; staff shall actively manage dispersal.

Queues after 23:00 to be supervised; customers encouraged to wait inside where practicable.

Any external seating/standing areas to close at 23:00.

A member of staff shall remove customer litter from the pavement within a 50-metre radius at close of business each night.

Waste collections and movements of waste to external areas shall not take place 23:00–07:00.

Kitchen extraction/filtration to include effective odour/grease control and be maintained to manufacturer recommendations; keep maintenance records.

Delivery driver conduct:

No engine idling, no horns, no shouting; drivers must wait quietly.

No congregating outside; drivers to wait inside for orders where space allows.

Lawful parking only; no obstructing pavements/driveways/cycle lanes; no double-yellow parking.

No smoking/vaping within 5 metres of the entrance or neighbouring residential doorways.

Engines off when stationary; no amplified music from vehicles.

A duty manager on each late shift shall be responsible for driver compliance and managing any nuisance outside.

If driver numbers cause a build-up after 23:00, the operator will stagger collections and pause new orders until cleared.

Last online/phone order by 02:45 to enable orderly close; display and monitor a duty manager contact number whenever open for LNR.

 - Films: no licence is required for 'not-for-profit' film exhibition held in community premises between 08.00 and 23.00 on any day provided that the audience does not exceed 500 and the organiser (a) gets consent to the screening from a person who is responsible for the premises; and (b) ensures that each such screening abides by age classification ratings.
 - Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
 - Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
 - Live music: no licence permission is required for:
 - a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
 - Recorded Music: no licence permission is required for:

- any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.
 - Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
 - Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
 - any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
 - any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
 - any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
 - any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.
