1. NOTICE IS HEREBY GIVEN that Croydon Council, on 09 February 2026, made the above Traffic Orders under the relevant sections of the Road Traffic Regulation Act 1984, as amended, and all other enabling powers.
2. **The purpose of the Orders is to revoke and reintroduce without any change to substance the prohibitions, restrictions and designations of stopping, waiting, loading, parking, traffic movement and speed limits and all the provisions related thereto of THE LONDON BOROUGH OF CROYDON currently in place by virtue of existing Map-based Traffic Management Orders into new consolidated Map-based Traffic Management Orders, as named above. A list of the orders to be revoked and consolidated into the above Orders is shown in the Schedule to this Notice.**
3. A copy of the Orders, which will come into operation on the 16 February 2026, and the Council's Statement of Reasons for making the Orders can be inspected between 10am and 6pm on Mondays to Fridays inclusive until the end of six weeks from the date on which the Orders were made at Croydon Central Library, Katharine Street, CR9 1ET. 4. Any person wishing to question the validity of any of the Orders or of any of the provision contained therein on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act, 1984 or that any of the relevant requirements thereof or of any relevant regulations made there under have not been complied with in relation to the Orders may, within six weeks of the date on which each of the Orders was made, make application for that purpose to the High Court.
