The premises will operate as a small restaurant/takeaway. The management will ensure compliance with all licensing objectives. Staff will be trained to promote public safety, prevent crime and disorder, prevent public nuisance and protect children from harm. The premises will be properly managed at all times.

b) The prevention of crime and disorder \*

CCTV will be installed and maintained in working order. Recordings will be kept for 10 days and made available to police upon request. Staff will be trained to deal with anti-social behaviour. Any incidents will be recorded in an incident log. The premises will not sell alcohol.

c) Public safety \*

The premises will comply with all fire safety regulations. Fire extinguishers and emergency lighting will be maintained. Staff will be trained in health and safety procedures. The premises will not exceed its safe capacity

d) The prevention of public nuisance \*

Customers will be asked to leave the premises quietly and respect local residents. No loud music will be played. Waste will be properly stored and collected. Deliveries and collections will be managed to minimise disturbance.

e) The protection of children from harm \*

Children will be permitted on the premises only when accompanied by an adult. No alcohol will be sold at the premises.
