

**DISABLED PERSONS PARKING PLACES – SCHEDULE 254**

The Croydon (Prohibition and Restriction of Stopping, Loading and Waiting) and  
(Free Parking Places) (No. 6) Order 2026

The Croydon (On-Street Charged-For Parking Places) (No. 6) Order 2026

NOTICE IS HEREBY GIVEN that Croydon Council on 01 June 2026 made the above Traffic Orders under section 6 of the Road Traffic Regulation Act 1984, as amended and all other enabling powers.

**1. The general effect of the Orders will be to:**

- a) Revoke the disabled parking places in the vicinity of: No. 5 Colebrook Road, Norbury, No. 15 Osterley Gardens, Thornton Heath, No. 317 Violet Lane, Croydon, No. 6 Westleigh Avenue, Coulsdon, and No. 31 Windmill Road, West Croydon.
- b) Designate new parking places at which vehicles displaying a disabled persons' badge may be left without charge or time limit in the following locations.

<b>Hythe Road, Thornton Heath</b>	<b>Outside No. 83 (replaces one space in a partial footway bay)</b>
<b>Kennelwood Crescent, Croydon</b>	<b>Outside No. 56</b>
<b>Kingswood Avenue, Thornton Heath</b>	<b>Outside No. 24 (replaces a one-space shared use payment/permit bay)</b>
<b>Malcolm Road, South Norwood</b>	<b>Outside Nos. 38 and 40</b>
<b>Norbury Court Road, Norbury</b>	<b>Outside No. 19</b>
<b>Norton Gardens, Norbury</b>	<b>Outside No. 53</b>
<b>Penshurst Road, Thornton Heath</b>	<b>Outside No. 53 and partially across the frontages of Nos. 51 and 55</b>
<b>Queen Elizabeth's Gardens, New Addington</b>	<b>Outside No. 14 and partially across the frontage of No. 16 (partial footway bay)</b>
<b>Raymead Avenue, Thornton Heath</b>	<b>Outside No 19</b>
<b>Reddown Road, Coulsdon</b>	<b>Outside No. 10a and partially across the frontage of No. 10 (replaces one space in a resident permit holders' bay)</b>
<b>Sutherland Road, Croydon</b>	<b>Partially outside Nos. 64 and 66 (replaces one space in a shared use payment/permit bay)</b>
<b>Tylecroft Road, Norbury</b>	<b>Outside No. 54 and partially across the frontage of No. 52</b>
<b>Tavistock Road, Croydon</b>	<b>Outside Westburn Court, No. 25 Tavistock Road</b>

2. Copies of the Orders, which will come into operation on 08 June 2026, and of all associated Orders, can be inspected between 10am and 6pm, at Croydon Central Library, Katharine Street, CR9 1ET for a period of six weeks from the date the Orders were made. 3. Any person desiring to question the validity of the Orders or of any provision contained therein on the ground that it is not within the relevant powers of the Road Traffic Regulation Act, 1984 or that any of the relevant requirements thereof or of any relevant regulations made there under have not been complied with in relation to the Orders may, within six weeks of the date on which the Orders were made, make application for the purpose to the High Court.
