# **VOA Rent Officers – Lettings Research Working in partnership with landlords and letting agents**

Annette Lewis, Valuation Office Agency's (VOA) role is to collect lettings information from a variety of sources including landlords, letting agents, educational establishments and others to help with statutory valuation work, and in their role supporting the work of the Office of National Statistics to produce a range of Private Rental Market Statistics. Annette has been working in partnership with the London Borough of Croydon to try and inform landlords, including attending Croydon's landlord forums.

Whist VOA regularly collect data from large numbers of estate and letting agents in Croydon and elsewhere, they are particularly keen to gather details of market rents for assured/shorthold tenancies from individual landlords and property companies, who let direct. They would not be able to use data on properties if they were let substantially below an open market rent.

Nationally over 12,000 agents and landlords provide VOA with details of over half a million open market rents. As more people like you add their input, so the lettings information improves in range and quality.
