CORPORATE PRIORITY/POLICY CONTEXT:

It is a Corporate priority as well as a statutory duty to maintain an up to date Local Plan, including the supporting guidance to the Local Plan. The Council's Croydon Local Plan: Strategic Policies Development Plan Document was adopted in 2013. The proposed withdrawal of the Supplementary Planning Guidance (SPGs) documents listed in this report will assist the Council in ensuring it is in compliance with this statutory duty and that the Croydon Local Plan is supported by up to date guidance, which provides clarity for the development management process, assisting and enabling growth in Croydon

AMBITIOUS FOR CROYDON & WHY ARE WE DOING THIS:

Providing clarity to the Development Management process with the removal of obsolete planning guidance will assist in the efficiency of the planning application process and help to deliver a vibrant borough of mixed sustainable communities with well-designed areas where people want to live, work and visit.

2. EXECUTIVE SUMMARY

2.1 Supplementary Planning Guidance (SPG) documents provide supplementary guidance for the Croydon Local Plan: Strategic Policies (2013) and the saved Unitary Development Plan policies and are material considerations when determining planning applications. Supplementary Planning Documents (SPD) were introduced by the Planning and Compulsory Purchase Act 2004 (as ameded) and, in accordance with paragraph 153 of the National Planning Policy Framework should be used 'where they can help applicants make successful applications or aid infrastructure and should not be used to add unnecessarily to the financial burdens on development'. The SPGs proposed to be withdrawn with immediate effect are those that no longer assist as planning guidance as they are out of date. Their removal will avoid potential confusion for both applicants and council officers and add clarity to the planning application process. SPGs which are intended to be superseded by Croydon

Local Plan: Detailed Policies and Proposals are proposed to be withdrawn at or around the time of the adoption of that Plan (anticipated late 2017).

3. DETAIL

- 3.1 The SPGs proposed to be removed are not referred to in the adopted Croydon Local Plan: Strategic Policies (2013) or in the saved Unitary Development Plan (UDP) policies although some of the SPGs are referred to in supporting text of the saved policies. The removal of these SPGs will therefore have no significant impact on the Local Plan or the saved Unitary Development Plan policies which are proposed to be replaced by the Croydon Local Plan: Detailed Policies and Proposals upon its adoption.
- 3.2 Croydon's SPGs proposed to be withdrawn with immediate effect are listed below. Those SPGs with an asterix were withdrawn from Croydon's website in 2015, as they did not comply with current legislation, or were identified as no longer in use or required by Development Management in the planning application determination process.

- 3.4 The Planning and Compulsory Purchase Act 2004 (as amended) and associated The Town and Country Planning (Local Planning) (England) Regulations 2012 are silent on Supplementary Planning Guidance and only refer to Supplementary Planning Documents. As a consequence of legislation being silent on the process for Supplementary Planning Guidance withdrawal the proposed approach is considered appropriate and proportionate. Nothwithstanding this, in the context of Supplementary Planning Documents, Regulation 15(2) makes provision for a Local Planning Authority to revoke a Supplementary Planning Document.

4. CONSULTATION

- 4.1 Consultation is not required on the withdrawal of the SPGs listed in the recommendation of this report as the guidance they provide is either covered in other statutory guidance and legislation, or by the Croydon Local Plan: Strategic Policies (2013), London Plan or is proposed to be provided on adoption of the Croydon Local Plan: Detailed Polices and Proposals. The Croydon Local Plan: Detailed Polices and Proposals will have been consulted on during its preparation and will be the subject of an Examination in public by a Planning Inspector on behalf of the Secreatry of State.
- 4.2 Notification of the withdrawal of the SPGs with be undertaken in accordance with Regulation 35 of The Town and Country Planning (Local Planning) (England) Regulations 2012.

5 FINANCIAL AND RISK ASSESSMENT CONSIDERATIONS

5.1 The recommendations of this report can be funded from the existing Spatial Planning Service budget for 2015/16.

2 The effect of the decision

The costs of preparing a notice of the withdrawal of the SPGs on the Council's website are accommodated within the existing Spatial Planning Service budget for 2015/16.

3 Risks

There is the risk that someone will seek to challenge the decision to withdraw policies, but this is considered as a low risk which can be mitigated by ensuring the statutory process is followed and documented. The risk that the Croydon Local Plan fails at examination and a policy void is created as certain SPGs are already withdrawn has been mitigated by proposing that the SPGs listed in Table 2 are not withdrawn until after adoption of the Croydon Local Plan.

4 Options

The alternative option of retaining the SPGs proposed for withdrawal could risk applicants referring to out of date SPG documents when making a planning application, further appeals and delays to the development management process.

5 Future savings/efficiencies

Clarity will be provided for the planning application process to all engared with the removal of out of date guidance and this will assist in creating a more efficient planning application service.

6. COMMENTS OF THE BOROUGH SOLICITOR AND MONITORING OFFICER

6.1 As set out earlier in this report, the Planning and Compulsory Purchase Act 2004 (as amended) and associated The Town and Country Planning (Local Planning) (England) Regulations 2012 are silent on Supplementary Planning Guidance and only refers to Supplementary Planning Documents. As a consequence of legislation being silent on the process for Supplementary Planning Guidance withdrawal a resolution made under the appropriate delegated authority from the Leader of the Council (under the 'Strong Leader' model of decision making and governance) is considered to be effective. Nothwithstanding this, in the context of Supplementary Planning Documents, Regulation 15(2) makes provision for a Local Planning Authority to revoke a Supplementary Planning Document.

9.1 There will be a positive environment impact in removing out of date SPGs from publication and reducing the amount of wasted paper from printing copies of this guidance, and ensuring incorrect information is not considered in planning applications.

10. CRIME AND DISORDER REDUCTION IMPACT

10.1 This report has no direct impact on Crime and Disorder reduction.

11. REASONS FOR RECOMMENDATIONS/PROPOSED DECISION

11.1 To ensure the Croydon Local Plan: Strategic Policies – Partial Review and Croydon Local Plan: Detailed Polices and Proposals are supported by up to date and relevant planning guidance documents and to assist an efficient development management service.

12. OPTIONS CONSIDERED AND REJECTED

12.1 Updating all the SPGs and creating new Supplementary Planning Documents was considered. However the majority of the updates would duplicate guidance already published by other statutory bodies such as the Mayor of London and the proposed detailed polices coming forward in the Croydon Local Plan: Detailed Policies and Proposals. Allocation of resourcing to this work would thus not be justified. Spatial Planning resourcing is concentrated on the development of the Croydon Local Plan and delivery of the development management service.
