- ◆ Questions will not be carried over to the following meeting, but it is of course in order for questioners to ask another question on the same or another topic before the next meeting.

What is the Labour Council doing to reduce the crime level in each ward in Croydon and to make every ward a better and safer place to live and work?

**Reply**

Across the borough the number of reported crime and anti-social behaviour incidents continues to reduce year on year with crime rates 5% less than those in the previous year. Anti-Social behaviour is also down by 10% with 1883 fewer incidents compared with the year before.

There is a whole raft of activity that we are undertaking in partnership with the police and a range of other agencies to continue to drive down crime. Some examples of this include:

An Integrated Offender Management model to provide a single coherent structure for the management of repeat offenders

Implemented the Croydon Connected gangs model to further strengthen early identification, prevention and enforcement opportunities across partnership organisation

A Stop and Search plan is now in place and a Stop and Search community monitoring group was established, which is made up of young people and local community representatives

Youth Support services have been focused on responding to local needs and building strong relationship with local communities

We have also run 4 anti-robbery campaigns resulting in a 35% reduction in robberies during the first two weeks in September when comparing the same period for the previous year

Why is the Labour Council not doing anything at all or adequately to reduce the crime level and fear of crime during the late evenings / night time in London Road between West Croydon train station and Croydon University hospital?

**Reply**

We are. Over the past year we have seen nearly 3,000 fewer offences reported, burglary is down 7% and robbery is down 26% when comparing end of year figures with the previous year. Anti Social behaviour is also down by 10% with 1883 fewer incidents compared with the year before.

There has been a raft of activity in the specific location you mention. Working closely with the Police and other agencies we have delivered four Anti-Robbery campaigns in and around the Broad Green area with the most recent operation taking place in September resulting in a 35% reduction of robbery incidents compared to the same time in the previous year. In addition, the environment has a significant influence on how people feel and with this in mind the West Croydon Improvement (WIP) project is seeing major improvements to the environment as well as providing practical support to residents and businesses including a dedicated Cleaner and Greener Co-ordinator to help tackle local environmental issues.

However despite all of this, the fear of crime remains a significant concern for residents and I accept that there is more that we can do. That is why addressing public confidence and the fear of crime is one of my top priorities as the Cabinet Member responsible for this area of work. We are continuing to look at ways to drive down crime but also understand the need to communicate this with people so that understand just how safe Croydon is.

### **Reply**

I very much welcome your question as it highlights something that is very important to a great number of people and improved what the borough looked like.

As you make clear, the decision was made by the previous Cabinet Member in November 2010 that the council would not enter future London in Bloom competitions as part of the budget discussions at that time. A result of this decision was that the council ceased to run the Croydon in Bloom competition.

I regret that I am not able to bring this competition back due to the considerable government cuts to the Council budget over the last 4 years. If the government recognises the importance of funding councils properly, and giving Croydon a fair share of available resources, I would fully support this competition being run by our Council in the future.

I am pleased though that seven individual parks were entered in London in Bloom this year resulting in 5 gold awards and 2 silver-gilts.

Local groups are encouraged to enter 'It's your Neighbourhood' run by London in Bloom on behalf of the RHS. This year three awards went to local groups, which is encouraging.

I would be pleased to support a voluntary sector initiative if this came forward, but as the council gets smaller, it is harder and harder to support such initiatives with staff time or money.

When will he call a public inquiry into the £140m spent on building new council offices, or into the £450m CCURV scheme?

**Reply**

We have [published details](#) in the July 2014 financial review about the cost to date of Bernard Weatherill House (BWH). It is now clear that the previous Conservative administration were not as open and transparent with the public about the costs, as they should have been. Indeed at one point Councillor Pollard claimed that the offices were "free".

In light of the information we now have, I believe we should do all we can to deliver the best deal for Croydon taxpayers from the building, rather than waste more money on a public enquiry. We will be reporting further information about BWH to Cabinet later this year.

We are currently in discussions with a number of potential partners from a range of sectors, private, public and educational, with a view to them leasing space in Bernard Weatherill House, which if successful, will generate income and provide better value for money for the people of Croydon. Use of BWH by partners will also help deliver the added benefit of a more cohesive mix and increase opportunities for joint working.

Further to the council answer in December and the subsequent decision to defer and review the programme of woodland clearance can we know what conclusions the council reached concerning the destruction of the trees and undergrowth and fencing of enclosures in Foxley Woods?

**Reply**

I visited these woods to inspect the work that has already been carried out, and works that could be carried out in the future.

The principle that I expect all work to be carried out to is based on an ecological or environmental or Health and Safety need.

We do not consider there has been any destruction of Foxley Wood. What there has been is the provision of woodland management works that are aimed to improve the structure of the wood, increase bio diversity and reduce the risk of trees falling into private properties.

It is intended that further works will be carried out this winter following communication with nearby residents together with the offer of meetings on site to explain the process.

We appreciate that some people have had concerns as to the effect on the wood, following these works, which resulted in a meeting last year with residents and woodland users. I can confirm that we will be working to guidelines from among others, the Forestry Commission, RSPB, Bat Conservation Trust and Bringing England's woodlands back to life"

This work will see a change from what is currently a dark wood with little regeneration or understory and declining trees to one where the works will provide healthy regrowth which have benefits to the fauna and flora of the wood and with better management the regrowth will be more stable.

We will be leaving trees that we feel are stable and where possible will leave as much screening as possible. I do appreciate people concerns and that some people do not like change but feel that it is important to carry on these works for the long term future of the woodland.

I am very impressed with the work undertaken by the council tree section and hope that we can showcase more of their excellent work in the future.

**Reply**

The vision for the “Cultural Quarter” has been discussed with key cultural stakeholders at a high level, at our ‘Ambitious for Culture’ seminar on 8 July. This seminar was attended by over 80 people from many different cultural organisations in Croydon.

Further consultation will take place as part of the development of the Cultural Quarter and the borough’s Growth Plan, with a comprehensive consultation and engagement being undertaken to ensure the area and development is meeting the needs of communities in Croydon. As soon as dates are in place for any engagement they will be announced by the Council.

The Cultural Quarter is part of a wider conversation with residents and cultural groups in Croydon to shape the cultural offer in the borough.

In view of the equalities statement in the affordable housing report (15 September Cabinet) are the Officers analysing bedroom size needs of those on Council transfer/waiting lists and in temporary homelessness accommodation, and how the affordable homes being built by developers match these in terms of unit size and location?

**Reply**

The council records and reports on the size of accommodation required by applicant households on the housing register (the "housing waiting list"). This includes households that have been accepted as homeless and are waiting for permanent rehousing. The information is published as part of the "Local Authority Housing Statistics Data Returns" on the [www.gov.uk](http://www.gov.uk) website. Returns for 2013/14 have not been published yet. In 2012/13 Croydon Council reported 8848 applicants on the housing register, of which 4427 required 1 bedroom accommodation, 2271 required 2 bedroom accommodation, 1458 required 3 bedroom accommodation and 692 required accommodation with more than 3 bedrooms.

The borough's housing requirement and is based on [Croydon's Strategic Housing Market Assessment](#) which analyses the housing stock, housing market trends, drivers of housing demand and provides estimates of future households requiring market and affordable housing. This assessment informed [Croydon's Local Plan: Strategic Policies](#). Policy SP2: Homes includes detail on the quantities and location of new housing, the proportion of affordable homes required on housing developments, the mix of homes required by size, quality and standards.

**Reply**

Creating a new Cultural Quarter in the town centre is one of the first steps in delivering our programme 'Ambitious for culture' in Croydon, to be at the heart of regeneration in the borough. We want to involve and connect communities to new activities and experiences, revitalise our district and local centres and improve people's health and wellbeing.

This will join up a number of key stakeholders, developments and activities in the town centre to form a significant coherent cultural offer and destination and complement the significant new developments around East Croydon and the retail centre.

The concept of the Cultural Quarter is at an early stage in development and further consultation will take place as part of its development and the borough's Growth Plan, with consultation and engagement being undertaken to ensure the area is meeting the needs of communities in Croydon. Why doesn't Croydon Council restrict the loading and unloading bay in Elmwood Road West Croydon 7am-7pm Monday to Saturday rather than 24 hours Monday to Sunday?

**Reply**

This loading bay was introduced at a similar time as the loading bays in nearby Hathaway Road and Nova Road, which operate 7am to 7pm, Monday to Saturday and were introduced around 10 years ago. The section of London Road between Elmwood Road and St James's Road can be very busy, which is why we have traffic signal operated junctions in both directions.

Encouraging loading on the side road reduces the incidence of goods vehicles parking on the main road (where there are 24 hour waiting restrictions) for these businesses, therefore lessening the chance of disruption to traffic flow and the bus services along this important transport corridor.

For each of the last four financial years and forecast for the current year, how many care leavers were there and how many were placed in each type of accommodation - foster carers, own flat, B&B or other emergency accommodation, supported accommodation, other?

**Reply**

Care Leavers aged between 18 and 21 years are the age group for which we have the statutory responsibility to ensure suitability of accommodation, and we have duties to advise and assist for care leavers aged up to 25 years in higher education. There are 202 care leavers aged 21+ and 540 care leavers aged between 18-21 years at this time.

**Care Leavers aged between 18 and 21 years**

2010/11 = 717

2011/12 = 641

2012/13 = 612

2013/14 = 572

2014 to date = 540

Data is not submitted for the annual return to government based on type of accommodation, but on the suitability of the accommodation, and until this year the Leaving Care Team did not collate data about the types of accommodation for care leavers. For past years this would require manual retrieval from each care leaver's personal file. Hence the information requested about types of accommodation relates to collated data for this year, shown below.

As a result of recent changes to our Social Care electronic recording system, from this month onwards the data for accommodation will be collected on a monthly basis and refined to include type of tenancy arrangement, HMO, private landlord, social housing etc.

**Reply**

I would like to thank Mr Shanmugaratnam for bringing this particular issue to my attention. I have asked officers within the highways team to investigate this proposal and if found to be practicable will add this to a future work programme. This will involve traffic and pedestrian surveys and some assessment of the engineering difficulties associated with laying signal cables in the bridge deck. A signalised crossing will also require the agreement of Transport for London who control and maintain all such installations. "How much of each component of the overspend in Quarter 1 was incurred in the period:

- (a) 1 April to the day before the new administration officially took office, and
- (b) from the day the new administration took office to 30 June?"

**Reply**

The Financial Performance Quarter 1 report that went to the Cabinet meeting in the 15<sup>th</sup> September set out a forecast of our expenditure against budget up the end of March 2015. Our projection for the year is an overspend forecast of £2.864m.

The key areas of overspend are set out below. The equivalent overspend for 2013/14 is set out in brackets. It is clear that in all areas there have been problems in managing demand against the budget for a significant amount of time and that these are not new problems that miraculously emerged after June this year.

- Placement costs for looked after children - £2.2m (£1.9m)
- SEN transport - £1.5m (0.5m)
- Care packages for adults - £1.5m (£2.5m)
- Temporary accommodation for homeless - £1.2m (£0.7m)

Work is ongoing to bring the overspend back to a balanced position and the latest position will be reported back to Cabinet in November.
