CORPORATE PRIORITY/POLICY CONTEXT/ AMBITIOUS FOR CROYDON:

The Croydon Local Plan 2018, supported by the Infrastructure Delivery Plan, is clear on the infrastructure needed to support and mitigate the growth outlined in the Local Plan. The borough's Community Infrastructure Levy will help fund this in full or in part.

The Corporate Plan 2018 – 2022 is clear as the borough's population grows it is essential to have the right levels of infrastructure and the borough's Community Infrastructure Levy can help fund this in full or in part.

FINANCIAL IMPACT

None – this report is a factual account of how much Community Infrastructure Levy has been collected, assigned and spent, and that there are no direct financial implications arising from this report.

The Leader of the Council has delegated to the Cabinet Member for Environment, Transport & Regeneration (Job Share) the power to make the decisions (the Leader of the Council's decision reference number: 23/14/LR) set out in the recommendations below

1. RECOMMENDATIONS

The Cabinet Member for Environment, Transport & Regeneration (Job Share) is recommended to:-

1.1 Approve the publication of the Croydon Monitoring Report 2017/18
Community Infrastructure Levy (Appendix 1) in accordance with Community Infrastructure Levy Regulations 2010 (as amended).

2. EXECUTIVE SUMMARY

- 2.1. The Croydon Monitoring Report 2017/18 Community Infrastructure Levy indicates the amount of the borough's Community Infrastructure Levy collected and assigned since its introduction in April 2013. Publication of the Croydon Monitoring Report 2017/18 Community Infrastructure Levy is in accordance with the Community Infrastructure Levy Regulations 2010 (as amended).
- 2.2. The Croydon Monitoring Report 2017/18 Community Infrastructure Levy highlights the following:
 - The total borough's Community Infrastructure Levy raised since introduction in 2013 to the 31st March 2018 is £17,975,346.
 - In 2018/19 from the 1/4/18 to 4/12/18 a further £8,712,034 of CIL contributions have been raised.
 - Resulting in a total of £26,687,380 raised.
 - To date £23,432,585 of contributions have actually been received, this
 is due to timing delays between raising invoices and the actual
 payment of contributions. This is normal.
 - Expenditure of borough CIL contributions to date is £13,915,143.
 - Part of the borough's Community Infrastructure Levy has been assigned to fund infrastructure types on the Council's Community Infrastructure Levy Regulation 123 list.

3. DETAIL

- 3.1 Regulation 62 of the Community Infrastructure Levy (CIL) Regulations 2010 (as amended) requires local authorities which collect CIL (excluding the collection of CIL on behalf of the Mayor of London) to prepare a report for the previous financial year. The report must include:
 - a) the total CIL receipts for the reported year;
 - b) the total CIL expenditure for the reported year;
 - c) summary details of CIL expenditure during the reported year including:
 - (i) the items of infrastructure to which CIL (including land payments) has been applied,
 - (ii) the amount of CIL expenditure on each item,
 - (iii) the amount of CIL applied to repay money borrowed, including any interest, with details of the infrastructure items which that money was used to provide (wholly or in part),
 - (iv) the amount of CIL applied to administrative expenses, and that amount expressed as a percentage of CIL collected in that year in accordance with that regulation; and

- (v) the total amount of CIL receipts retained at the end of the reported year.
- 3.2 The report must be published on the Council's website no later than the 31st December following the end of the financial year.
- 3.3 The report will be published as part of the Croydon Monitoring Report 2017/18. The Croydon Monitoring Report 2017/18 is a requirement of s.35 of the Planning and Compulsory Purchase Act 2004 (as amended). It must include a review of progress in preparing the local plan for the borough against the published timetable, a review of the effectiveness of existing planning policies, and a housing trajectory detailing the Council's performance against London Plan/Croydon Local Plan targets for new homes in the borough and the predicted future supply of new homes in the borough.
- 3.4 Only approval for publication of the Croydon Monitoring Report 2017/18 CIL (the Monitoring Report) is being sought under the delegated authority from the Leader. The remaining parts of the Croydon Monitoring Report 2017/18 will be reported to the Cabinet Member for Environment, Transport & Regeneration (Job Share) in early 2019.
- In the first four years of implementation of the borough's CIL (from 1st April 2013 to 31st March 2018) a total of £17,975,494 has been collected through it. In the following eight months up to 4th December 2018 a further £5,457,239 of borough's CIL has been collected.
- 3.6 The Council's Infrastructure Finance Group ensures that CIL and planning obligation income is spent on essential infrastructure needed to support growth in the borough as set out in the Croydon Local Plan, Council's Capital Strategy, Infrastructure Delivery Plan, Growth Zone Programme and with regard to planning obligations in the parent Section 106 agreement.
- 3.7 The Council's Infrastructure Finance Group and Growth Board approved funding for the following as items on the Council's Capital Strategy from the 2017/18 borough CIL income. This aligns with the February 2017 Full Council Budget Report agreeing to assign borough's CIL to the Council's Capital Strategy to offset borrowing:-

- 5.2 To date £13,915,143 has been spent. Leaving a balance of £12,772,237 (inclusive of administration, Meaningful Local proportion and borough CIL).
